INDIGENOUS VITAL EVENTS REGISTRATIONS, 1917-1956

INTRODUCTION

This guide offers information for searching vital event registrations for Indigenous individuals in BC between 1917 and 1956. It also provides some historical background on the exclusion and separation of Indigenous vital event registrations, the designation of "Indian registrations" between 1917-1956, and how to use the BC Archives <u>Genealogy Collection</u> to locate specific registrations and to access the records themselves.

HISTORICAL BACKGROUND

The *Births, Marriages and Deaths Act* of 1872,¹ specifically excluded Indigenous and Chinese populations from registration, although this exclusion was not always observed.² In 1888, the exclusionary section was removed,³ and in 1897 the Act was made explicitly applicable to "all races and nationalities, including all Indians and persons of Indian blood, Chinese and Japanese".⁴ Two years later, however, an amendment made the Act applicable to "all races and nationalities except persons who are Indians within the meaning of the Act of the Dominion Parliament respecting Indians."⁵

In 1916, although the exception clause was retained, the legislation was amended to allow Indigenous registrations stating that "For the purpose of compiling statistics of births, deaths and marriages of such Indians [i.e., defined as such by federal legislation] the Registrar may accept returns ... by the respective Indian Agents in the Province."⁶ Special forms were to be used and the returns were to be "kept separate and apart from the other returns."⁷ These registrations were designated as "Indian registrations".

In 1943 the exception was removed,⁸ and the registration of Indigenous births, marriages, and deaths was thereby made mandatory, but special registration forms and the separate filing of returns were retained as was the use of Indian Agents as ex officio District Registrars. Not until 1957 was the use of separate forms and returns eliminated.⁹

Registration of previously excluded Indigenous births, marriages, and death commenced in 1917 under the amended Act with Indian Agents submitting returns monthly. From 1917 to 1956 "Indian registrations" were recorded in separate volumes with a separate numbering system. The microfilm reels containing copies of these records are found within separate sections of the microfilm cabinets located within the BC Archives Reference Room.

SEARCHING VITAL EVENT REGISTRATIONS

The date range of publicly available vital event records varies as additional records are released by the <u>BC Vital Statistics Agency</u> each year. Both Indigenous and non-Indigenous records are withheld for the following time periods before being publicly released:

- Birth registrations—120 years¹⁰
- Marriage registrations—75 years
- Death registrations—20 years

For more recent records, contact the **BC Vital Statistics Agency**.

The BC Archives <u>Genealogy Collection</u> acts as a searchable, online index to Indigenous and non-Indigenous births, marriages, and deaths. It includes the most up-to-date release of records from the <u>BC Vital Statistics Agency</u>, it provides access to any registration records that have been digitized, and it offers multiple search fields or access points.

Birth, marriage, and death index entries provide limited information about a person and event, but are not the registration records themselves. For complete information, the actual registration records must be consulted.

Occasionally, there are two or more entries for the same registration in the collection. This can occur for a variety of reasons, primarily variant spellings, index loading problems, and amended registrations. In the case of the first two, the entry will have the same registration number, in the case of the third, there will be two numbers, one for the original registration and one for the amended one.

In a number of instances, there will be entries for registrations which fall within the time limitations but which are not available on the microfilm reels released for public access. These are often delayed registrations. They are generally designated as "NOT FILMED" or they lack a reel number. A few, however, falling at the end of the latest release year, have a microfilm reel number but, because that reel contains registrations from the following year, it has not yet been released. Copies of these and the "NOT FILMED" registrations can be obtained from the <u>BC</u> <u>Vital Statistics Agency</u>.¹¹

ACCESSING REGISTRATION RECORDS

Vital event registration records located via the BC Archives <u>Genealogy Collection</u> can be accessed in two possible ways:

- digitized
- microfilmed

Digitized registrations

Records released from 2010 onward are uploaded in digital format, as a JPEG image. If you find a record listing via the BC Archives <u>Genealogy Collection</u> click on red .jpg link(s) to view, save, and/or print a record.

Additional records are being retroactively digitized as <u>BC Vital Statistics Agency</u> resources allow.

Microfilmed registrations

Records released prior to 2010, that have not yet been digitized, can be retrieved from microfilm within the BC Archives Reference Room"

- 1. Note the event date, Registration number, and the BC Archives Mfilm number for each record.
- 2. The microfilm reels for Indigenous births and deaths are stored in designated "Indian birth" or "Indian death" areas of the microfilm cabinets located in the Reference Room.¹² If you cannot find a reel within this area, particularly for records from 1877-1899, try looking within the non-Indigenous registration reels.
- 3. Use microfilm readers within the Reference Room to view the records, which can be printed or saved onto a USB as a PDF copy. Archival staff in the Reference Room can assist with locating the reels and getting started with the microfilm readers.

SEARCH TIPS

Birth registrations

Indigenous birth registrations collected as "Indian births" between 1917-1956 are considered delayed registrations as they were not received by Vital Statistics until after 1916.¹³ They have all have been assigned volume number 995.¹⁴ The earliest birth registration dates back to 1868.¹⁵

Most Indigenous birth registrations, up to 1903, have been digitized and are accessible directly from the BC Archives <u>Genealogy Collection</u>. If not available online, they may be available on microfilm at the BC Archives (if a BC Archives Mfilm number has been provided) or they may need to be requested from the <u>BC Vital Statistics Agency</u>.

They were bound in volumes, initially in sequentially-numbered annual volumes, starting with Volume 1 in 1917 and then, commencing in 1946, by year using a single volume number, 095. During the same time period, delayed Indigenous birth registrations were bound in a separate set of volumes numbered 795 and 995-998. A special form was used, which included additional information such as First Nation community. This form was altered in 1943 and discarded in 1956 when Indigenous registrations were no longer separated from non-Indigenous registrations and only the general form was used.

Marriage registrations

From 1917 to 1956 Indigenous marriage registrations were recorded in separate volumes with a separate numbering system. Each volume, starting with 1917 as Volume 1, corresponds to a year. The registration numbers are, however, in a single continuous sequence to 1934 (1-2286).

This creates a potential problem for finding registrations on reel B13892 (1926) when the numbers change from three digits to four digits. Because only the last three digits of the official registration number appear in the index entry, registrations numbered 001000-001113 will be shown as 1926-09-010000 to 1926-09-010113 (1926, volume 10, last three digits of registration number). They appear on the microfilm reel in the proper sequential order according to the original four-digit registration number but not according to the three-part index registration number (i.e., 1926-09-010000 will follow 1926-09-010999, as marriage registration number 1000 immediately follows 999).

Another problem occurs on reel B13888. The reel includes 1922 registrations as Volume 6 as well as Volumes 26 and 26A, which contain marriages prior to 1922 which were not registered until 1942. Because the six-digit part of the index registration number does not distinguish between the 26 and 26A volumes, the numbers for registrations 207 to 498 in Vol. 26 and 1207 to 1468 in Vol. 26A will have the same six-digit number. For example, the number 026253 will be used for an 1873 marriage with a registration number of 000253 *and* a 1906 marriage with a registration number of 1253. Volume 26 is comprised mostly of registrations from Kamloops and district and Volume 26A of registrations from the Fort St. James district and northern BC so the place of marriage may provide a clue. If not, both volumes may need to be checked to locate the correct registration. (Note that numbers 1 to 206 do not appear on the reel.)

Each volume includes a certain number of registrations from previous years. For purposes of finding the registration, the year can be ignored.

Death registrations

From 1917 to 1946, Indigenous death registrations were recorded in separate volumes with a separate numbering system and microfilmed on separate reels for "Indian deaths".

- 1917 to 1945 the registration numbers consist of a prefix (i.e., a sequential volume number starting with Volume 1 in 1917) followed by a sequentially assigned number. To locate registrations filed in volumes1-29, the volume numbers can be used.
- 1946 to 1956 the numbers have a single prefix (volume number 95) followed by a sequential number starting at 1 at the beginning of each year. To locate a record, advance the microfilm reel to the correct year as indicated in the title strip found on each frame. Then use only the final three digits of the finding number to locate the record.

Volume years are the years of registration, not necessarily the year a death occurred. Each volume includes a certain number of registrations from previous years, going as far back as 1916.

From 1877 to 1899, Indigenous death registrations may also be found with non-Indigenous death registrations.
